SAKARYA UNIVERSITY OF APPLIED SCIENCES ASSOCIATE AND UNDERGRADUATE INCOMING STUDENT ACCEPTANCE DIRECTIVE

SECTION ONE

Purpose, Scope, Basis, and Definitions

Aim

Article 1– (1) The purpose of this directive is to determine the procedures and principles regarding the Admission of Foreign Students to Sakarya University of Applied Sciences associate degree and undergraduate programs.

Scope

Article 2–(1) This directive, regarding the admission of foreign students to Sakarya University of Applied Sciences associate degree and undergraduate programs, determining the quota, and application conditions, covers assessment, placement, enrollment-admission, start times, and other issues.

Rest

Article 3—(1) This Directive has been prepared on the basis of the Higher Education Law No. 2547 and the Law No. 2922 on Foreign Students Studying in Turkey, and the decisions of the General Assembly of Higher Education dated 21.01.2010 and 25/08/2011 on the principles of accepting students from abroad.

Definitions

Article 4 –(1) In this Directive;

- a) Candidate: Foreigner students who apply to the units affiliated with Sakarya University of Applied Sciences
- b) Unit: Faculty, School, and Vocational School affiliated to Sakarya University of Applied Sciences,
- c) Student: Foreign students whose applications are accepted to the units affiliated with Sakarya University of Applied Sciences,
- c) Program: Programs that carry out educational activities at the undergraduate and associate degree levels,

Rector: Sakarya University of Applied Sciences Rector,

- e) SADEM: Sakarya Language Education-Training Application and Research Center,
- f) Senate: Sakarya University of Applied Sciences Senate,
- g) University: Sakarya University of Applied Sciences,
- ğ) TRNC: Turkish Republic of Northern Cyprus,
- h) TR: The Republic of Turkey,
- 1) ÖSYM: Assessment Selection and Placement Center,

SECTION TWO

Principles Regarding the Admission of Students from Abroad The application requirements are:

Article 5– (1) Candidates who are in the last year or graduated from a secondary education institution whose equivalence has been approved by the Turkish Republic Authorities at the high school level can apply to the programs that the university has declared to accept foreign students and those who provide sufficient points in one of the exams specified in the supplementary list.

- a) Provided that they are in the last year of high school or have graduated:
- 1. Foreign nationals,
- 2. Being a Turkish citizen by birth and leaving Turkish citizenship by the Ministry of Interior Those who have obtained a permit and certify that their underage children, who are registered in the Turkish Citizenship Renunciation Document, have a Document on the Exercise of the Rights Granted in accordance with the Turkish Citizenship Law (Article 7 of the Turkish Citizenship Law No. 5901 states that "Child born in a marriage union to a Turkish citizen mother or father in Turkey or outside of Turkey) is a citizen of Turkey.", and it is beneficial for the candidates who will apply for the admission quota from abroad to examine the Turkish Citizenship Law.),

- 3. Those who have dual nationality who are foreign nationals and then acquire Turkish citizenship,
- 4. a) Turkish citizens who continued their secondary education abroad before 01/02/2013 those who have completed the last three years of their secondary education (high school) in a foreign country excluding the TRNC (including those who have completed all of their secondary education (high school) in a Turkish school opened by the Ministry of National Education in a foreign country other than the TRNC) who can apply for student admission quotas from abroad,
- b) Candidates who started secondary education abroad after 01/02/2013

Those who have completed their entire secondary education (high school) in a foreign country excluding the TRNC (including those who completed their entire secondary education (high school) in a Turkish school opened by the Ministry of National Education in a foreign country other than the TRNC) for admission quotas from abroad,

5. TRNC nationals residing in TRNC and completing secondary education in TRNC Those who have GCE AL exam results and college in other countries between 2005-2010

and those who have or will have GCE AL exam results by enrolling in high schools and receiving education,

- b) Candidates whose applications are not accepted;
- 1. Those who are Turkish nationals and have completed their entire secondary education in Turkey or Northern Cyprus,
- 2. Northern Cyprus nationals (except those who have completed their secondary education in TRNC high schools and have GCE AL results, and those who have or will have GCE AL exam results by registering and training in colleges and high schools in other countries between 2005-2010),
- 3. Those whose first nationality by birth as defined in clause 2 of article a is T.C. dual nationals (except for those who meet the conditions in clause 4 of article a),
- 4. Dual nationals, one of whom is TRNC (excluding those who have completed their entire secondary education in TRNC high schools and have GCE AL results, and those who have or will have GCE AL exam results by registering and studying at colleges and high schools in other countries between 2005-2010),
- 5. Those who are Turkish citizens and have dual citizenship, whose first nationality is Turkish by birth, as defined in clause 2 of article a, who studied at schools within the embassies in Turkey and foreign high schools in Turkey,
- 6. Persons who have acted against the Republic of Turkey with their ideas and actions or who have been removed from their Turkish citizenship as a sanction,
- 7. Those who have benefited from scholarships or higher education opportunities given to foreign governments by the Government of the Republic of Turkey through cultural agreements, cultural exchange programs and similar arrangements, and those who are citizens of the Republic of Turkey who graduated from Western Europe Open Education High School Programs (those who reside abroad while studying in Western European Open Education High School programs) not including),
- 8. Foreign nationals who have been dismissed from a higher education institution in Turkey due to a disciplinary offence,
- 9. If Turkish citizens have completed a high school in Turkey, their applications are not accepted even if they, later, complete a high school abroad.

SECTION THREE

Prerequisites for Application, Exams to be Used in Application, Base Points and Student Quotas

Prerequisites for Application

Article 6 - (1) The following are prerequisites for applicants:

a) To meet the conditions listed in clause a of paragraph 1 of Article 5 of this directive.

- b) To have obtained the minimum scores specified in the exams listed in the annexe of the directive.
- c) For the applicant, not to have attained the age of 25 as of the date of application.

Exams and base scores that can be used in the application

- **Article 7** (1) Students to be accepted from abroad; In order for them to be admitted to university programs, the list of national and/or international exams they have taken and the minimum scores they will receive, according to the type of program they have applied for, are also given (Annex -1).
- (2) The validity period of university entrance exams (SAT, etc.) is 2 (two) years. If necessary, this list (Annex -1) is renewed by the Senate.
- (3) Exams in the status of high school graduation exams are valid indefinitely (ABİTUR etc.).
- (4) Candidates who have a score that is not included in the list given in Annex 1 can also apply together with the documents promoting the score type. Equivalence transactions in this regard are carried out by the commission.
- (5) The base scores of the exams in the table in Annex-1 can be changed with the decision of the Senate.
- (6) Priority is given to those who have received gold, silver and bronze medals from the international science Olympics recognized and attended by TÜBİTAK.

Student Quotas

- **Article 8** (1) The quotas for international students to be taken for the relevant year for the departments that provide associate degree and undergraduate education at our University, approved by the Higher Education Council for the admission of foreign students from abroad, are decided by the University Senate with the recommendation of the International Student Coordinators and published in the guide issued by OSYM. It is submitted to the Board.
- (2) In case the Senate decides to fill the vacant quotas with additional placement due to no applications for the quotas and/or no registration of the placed candidates, the above provisions shall apply.
- (3) The University is free to fill the announced quotas or not. When necessary, the quota is transferred between programs.

Application principles

- **Article 9-** (1) The application requirements, application dates, documents to be requested in the application and the quotas approved by the Higher Education Council are announced on the website of the University on the dates determined in the academic calendar.
- (2) Applications are made to the University Registrar's Office on the dates specified in the announcement personally, by mail or online. For applications to be made by mail, the deadline for evaluation is taken into account. In applications made by mail, application documents received after the application deadline will not be processed due to postal delays. The application fees of the candidates who withdraw their applications after the application to the university and those who cannot be placed in any program are not refunded. The information provided in the applications made online is considered correct, but the registration procedures of those who are found to have given misleading and false information during the evaluation and final registration or at a later date will be cancelled.
- (3) International student candidates can apply to a maximum of 10 programs. Placement is made according to the candidate's preference priority.
- (4) International student candidates must be graduate or senior students in order to apply and make a choice.
- (5) Pre-registration of international student candidates who apply to programs that accept students with a Special Talent Examination is taken if they are accepted in the relevant program. If these candidates are successful in the Special Talent Exam to be held by the relevant unit, final registration is made.
- (6) The locations and dates of the international student admission exams are determined by the International Student Coordination Office. Exam fees are determined by the university administrative board and deposited into the relevant account to be opened for international students.

Evaluation of applications

- **Article 10** (1) Applications of students applying to the University from abroad are evaluated by the relevant commission and submitted to the approval of the board of directors of the unit.
- (2) In the evaluation of the applications, criteria such as the success of the candidate in national/international examinations, diploma grade, and the place of the graduated school in the national and international rankings are taken into consideration.
- (3) Candidates who apply to programs that admit students with a special talent exam must also be successful in the Special Talent Exam to be held by the University.

Evaluation of the applications is made according to the issues specified in the special talent examination directive of the relevant units.

- (4) The commission determines the main and substitute candidates as much as the number of quotas from among the candidates whose qualifications are suitable.
- (5) If the diploma and achievement scores are equal according to the principles set in Annex-1, which is the basis for the evaluation, the younger candidate is preferred.
- (6) As a result of the evaluation, the other preferences of the candidate who is placed in one of his/her preferences as a primary or substitute are not taken into consideration.
- (7) The scores of students with different diploma score types are evaluated by converting them into a hundred (100) system.
- (8) Meeting the application conditions does not guarantee admission to the program.
- (9) Candidates accepted to undergraduate programs are sent an official acceptance letter to the e-mail addresses they declared to the Registrar's Office during the online application so that they can obtain a visa.

Announcement of results

Article 11 - (1) Application results are announced on the web pages of universities and related units.

Final registrations are made on the basis of this announcement.

- (2) An acceptance letter is sent to the candidates who have the right to enrol in the university.
- (3) Records are made by the relevant unit. Candidates must come to the registration in person. It is not possible to register online or by mail.

Placement

Article 12 - (1) Placement;

- a) The placement list for the accepted candidates is announced on the University's website on the dates specified in the academic calendar.
- b) Applications for the vacant quotas can be accepted again on the dates to be determined by the University.
- c) The number of students from the same country admitted to a unit cannot exceed 20 per cent of the total quota for international students of the programs affiliated with this unit. In case the quotas are not filled, candidates are placed in the unfilled quota in order of success points, regardless of this rule.
- ç) The university is free to fill the quotas or not. Meeting the application conditions does not require acceptance for placement.
- d) International student candidates can apply to a maximum of 10 programs.
- e) Students who do not register on the registration date lose their right to register.
- f) If the specified quota is not filled, if deemed necessary, students can be recruited by taking into account their score and preference, provided that the students apply in person outside the academic calendar by the commission formed.

Financial Security

Article 13- (1) Candidates applying within the scope of the quotas must certify that their financial situation is sufficient to continue their higher education in our country, by showing a financial guarantee. The quality and amount of financial security and the documents to be requested in this context are determined by the University Administrative Board for each academic year.

Contribution / Tuition Fee

Article 14- (1) The amount of contribution and tuition fees to be collected from international students who have the right to study at our university are determined by the University Administrative Board within the framework of the decision of the Council of Ministers.

(2) The principles regarding the exemption or discount conditions from the tuition fees of the students are determined by the University Administrative Board.

Study Visa

Article 15- (1) a) Candidates are required to go to the Turkish Foreign Representative Office in their country (or the nearest) together with the Letter of Acceptance and obtain an "Education Annotated Visa".

b) An Education Annotated Visa is not required for students who are in the status of foreigners who will not be required to have a Study Visa within the framework of the principles set by the General Directorate of Security.

Registration

Article 16 - (1) Candidates who are entitled to become students register with the Registrar's Office on the dates determined in the academic calendar. Registration of students with missing documents will not be accepted.

- (2) The documents required for registration are:
- a) The original of the High School Diploma and its Turkish translation approved by the notary public or Turkish Foreign Representatives
- b) The original of the 'Equivalence Certificate', which shows that the candidates' high school diplomas are equivalent to the diplomas obtained from Turkish high schools, and which will be obtained from the Ministry of National Education (Education Attaché) or the Turkish Embassy (Educational Counseling Office) in their country. Foreign Language and Turkish proficiency certificate with international validity, if any.
- ç) The original of the document showing the graduation grade point average and a certified copy from the Embassies or Consulates of the Republic of Turkey translated into Turkish or English,
- d) The original the exam result document to be used in the application and a certified copy from the Embassies or Consulates of the Republic of Turkey translated into Turkish or English,
- e) A certified Turkish copy of the passport or identity card obtained from official authorities or approved by the Turkish Embassy or Consulate,
- f) Bank receipt showing that the contribution/tuition fee has been paid,
- g) Photograph (6 pieces),
- ğ) Certified and approved Turkish copy of the Study Annotation Visa to be obtained from Foreign Representatives,
- h) A document showing valid health insurance throughout their education,
- 1) An official or notarized document or undertaking that the candidates have an income above the amount that will enable them to continue their education at the university.

(Foreign students who will continue their higher education at our university are required to certify that their financial situation is suitable for their education by the civil units in their country or from their consulates in Turkey. The amount of financial security required for this is announced on the University website each year, along with other conditions.),

i) A copy of the Turkish Identity Number statement or a copy of the Identity Card of the candidates with Turkish nationality,

- j) A document approved by the official authorities regarding the military service status of male candidates of Turkish nationality,
- k) The original the GCE AL exam result document of the TRNC national candidates who have completed their entire secondary education in TRNC high schools,
- l) A copy of the residence permit (Foreign candidates, who are obliged to apply to the Police authorities and obtain a residence permit after registration, must submit a copy of the residence permit),
- (3) Holders of a "Turkish Pedigree Document" must present it during registration. Documents that students will bring later do not change their status at the time of admission.
- (4) Students admitted to undergraduate programs from abroad are required to register in the first semester they are admitted to the program. In order for these students to register, they must have an Education Annotated Visa or be in the status of foreigners who will not be required to have a Study Visa within the framework of the principles determined by the General Directorate of Security.
- (5) Among the candidates who have earned the right to register, those who do not register within the registration period to be announced or those who cannot submit the documents required for registration shall be deemed to have lost their right to register.
- (6) In order to be able to reside in Turkey to study, foreign students admitted by registration must obtain a student residence permit issued by the competent authorities of the Ministry of Interior within the framework of the provisions of the Law on Foreigners and International Protection No. 6458.
- (7) Foreign students admitted to the University are subject to and are obliged to comply with the laws and regulations of the University.

SECTION FOUR

Language of Instruction and Education-Teaching, Exemption and Educational Sufficiency Language Proficiency Status

- **Article 17** (l) Candidates who are accepted to programs whose language of instruction is Turkish are required to have a Turkish Proficiency Certificate in order to start their education after registration. As a Turkish Proficiency Certificate; Proficiency exemption exam results issued by Yunus Emre Institute or our University are valid. (TÖMER documents obtained from Yunus Emre Institute must have been obtained within the last 2 years as of the date of enrollment in the university).
- (2) All students who will enrol in SUBU associate, undergraduate and graduate programs submit their Language Proficiency Documents, if any, to SADEM for equivalency as of the registration date. All students whose Turkish level is not sufficient to take the Turkish Proficiency Exam conducted by SADEM. SADEM determines the principles of this exam. The starting time of the students enrolled in the programs whose language of instruction is Turkish is determined according to the results they get in the Turkish Proficiency Exam organized by SADEM after registration.
- (3) Candidates with insufficient Turkish proficiency are registered with SADEM. Students who successfully complete a one-year Turkish education at SADEM and pass the Turkish proficiency exam begin their academic education.
- (4) Students admitted to the University in accordance with the provisions of this directive for programs requiring compulsory foreign language (English) preparation, those who cannot prove their English language proficiency with any language exam document accepted by the Senate, in the English Proficiency Exam held at the beginning of the academic year. Those who are unsuccessful are accepted to the English Preparatory Program.
- (5) International student candidates who are absent from Turkish preparatory education are not taken to the end-of-course exam and are directed to repeat the course. However, if a student is absent from the same course 3 times in a row, he is dismissed from SADEM and the university.

(6) The duration of foreign language preparatory or Turkish preparatory education is a maximum of 2 years. Students who cannot document their proficiency at the end of 2 years will be deregistered.

Exemption

- **Article 18** (1) He completed his secondary education in the Republic of Turkey. An international student with a Turkish High School diploma who completed in institutions affiliated with the Ministry of National Education, if he/she proves with a transcript that he/she completed all 4 years of high school education in Turkey, and registers for a higher education within 2 years from the date of graduation, he/she is deemed exempt from Turkish preparatory education.
- (2) An international student who has a diploma from Maarif Foundation schools, who has the right to enrol in an Associate Degree Undergraduate program, is exempted from Turkish preparatory education if he/she registers for higher education within 2 years from the date of graduation if he/she proves with a transcript that he/she has taken Turkish language course in every year of high school education.
- (3) An international student who has completed an Associate Degree Undergraduate or graduates education at any university in Turkey is exempt from Turkish preparatory education if he/she registers for an equivalent or a higher education within 2 years from the date of graduation.
- (4) If students who completed their high school education in the Turkish Republic of Northern Cyprus (TRNC) apply to associate, undergraduate and graduate education within 2 years, they are deemed exempt from Turkish preparatory education.

Education Qualification

- **Article 19** (1) In order for students to register for the first time at Sakarya University of Applied Sciences Faculty and Vocational Schools, they must be at least B2 level in the fall semester; In the spring semester, he/she must have a Turkish certificate issued by SADEM or Yunus Emre Institute, showing that he/she has been successful at least C1 level. Students who register with a B2 certificate in the fall semester, it is not required to have a C1 certificate in the spring semester.
- (2) Students who will start their undergraduate education with B2 must obtain the C1 certificate by the end of the 4th semester. If students do not receive their C1 certificates by the end of the 4th semester and do not submit them to the student affairs, they cannot take courses from the 5th semester.
- (3) Students who do not fulfil the C1 qualification requirement cannot graduate.

Turkish Level

Article 20 – (1) Turkish Language Test is given by the SADEM unit to determine the Turkish level of the candidates who do not have a Turkish Proficiency Certificate (Yunus Emre Institute and SADEM Turkish Proficiency Certificate).

- (2) As a result of the Turkish test:
- a) Those who score between 85-100 are C1 (Turkish is sufficient, they can continue their education),
- b) Those who score between 70-84.99 are B2 (His Turkish can improve in a short time, and he can continue his education. However, he has to make the Turkish proficiency level C1 until the end of the 4th semester.),
- c) B1 scores between 50-69.99 points (his Turkish is insufficient, and he cannot continue his academic education),
- d) Those who score between 36-49.99 points are A2 (his Turkish is insufficient, and he cannot continue academic education),
- e) Those who score between 0-35.99 are accepted at the A1 (Turkish level is insufficient, they cannot continue their academic education).

Turkish Preparatory Program

Article 21 – (1) Candidates who do not have a Turkish Proficiency Certificate and who are not successful as a result of the Turkish Test conducted by the SADEM unit; At the end of the Turkish Preparatory Program to be opened within the body of Sakarya University of Applied Sciences SADEM, it has to increase its Turkish level to at least B2 level. Students who fail to do so at the end of the second year lose their right to study at Sakarya University of Applied Sciences.

Students/candidates who do not have a Turkish proficiency certificate and who are not successful in the Turkish Proficiency exam administered by Yunus Emre Institute or SADEM must enrol in the Turkish Preparatory Program to be opened within SADEM.

SECTION FIVE

Miscellaneous and final provisions

Authority

Article 22 – (1) With the consent of the Rector, a "Foreign Student Office" is established in order to prepare documents and catalogues introducing our country and our University in order to allow students from abroad to choose our University, to participate in international education fairs, and to assist students who apply or come from abroad.

(2) Receiving applications from the quotas determined and announced by the University Senate according to the countries, to the quotas of some countries determined, evaluation of the applications, placement process, Turkish level determination exam, one-year Turkish education for those whose Turkish is insufficient. can be executed by The candidate's registration process and education in the program are done by his/her own University.

Additional Terms

Article 23–(1) For the final registered student; Sakarya University of Applied Sciences Undergraduate and Associate Degree Education and Examination Regulations and Senate Principles are applied.

Article 24 – (1) The University Senate shall; may make necessary arrangements, provided that they do not contradict the relevant Law, Regulation, Higher Education General Assembly Decisions and the provisions of this Directive. In addition, the University Senate can make regulations regarding the implementation.

General provisions

Article 25 – (1) Applications of candidates who make false statements or are found to mislead the administration with any action or transaction are rejected. If the registrations of these candidates have been made, they will be cancelled. If this situation is determined before the start of the academic year, the candidates from the reserve list are registered instead of these candidates. Necessary legal actions are taken against those whose actions constitute a crime.

General Health Insurance

Article 26- (1) Medical expenses of foreign students are covered by the health insurance to be taken out by the students and by themselves.

Notification

Article 27- (1) All kinds of notifications to students; It is done in writing to the e-mail address they provide while registering or by being announced in the unit applied by the student. Students who report an incorrect or incomplete address or do not report a change of address are deemed to have been notified if notification is made to their existing address. If the student changes his/her contact information, he/she is obliged to notify the International Student Coordinator within 15 (fifteen) days.

Obligations of International Students

Article 28- (1) International students coming to or staying in Turkey to study are subject to the provisions of the relevant legislation in Turkey.

Disciplinary affairs

Article 29- (1) Disciplinary work and procedures of students are carried out in accordance with the provisions of the Higher Education Institutions Student Disciplinary Regulation.

Cases where there is no provision in the directive

Article 30- (1) In cases where there is no provision in this Directive; The Law No. 2922, the Regulation on Foreign Students Studying in Turkey and the principles regarding the admission of students from abroad determined by the Council of Higher Education, Sakarya Applied Sciences University Associate Degree and Undergraduate Education and Training Regulation and other relevant legislation provisions and Senate decisions are applied.

Force

Article 31– (1) This Directive enters into force on the date it is accepted by the Sakarya University of Applied Sciences Senate and approved by the Council of Higher Education.

Executive

Article 32–(1) The provisions of this Directive are executed by the Rector of Sakarya University of Applied Sciences.

APPENDIX: 1: List of Accepted Exams, Diplomas and Scores in Application

Types of exams to be accepted and minimum scores are given in Table 1, Table 2, Table 3 and Table 4. Firstly, the exam grade of each applicant is converted into a score out of "100", and then the percentages are taken according to the exam types (Table 1, Table 2 and Table 3) and accordingly the Entry Score is calculated.

100% of the scores of the exams specified in Table 1 are taken. For all Undergraduate and Associate Degree programs 100% of them are taken.

Apart from these exams, the evaluation of success from other exams that can be accepted by Sakarya University of Applied Sciences (based on the criteria of having a high school diploma first) will be made by the Education Commission in case of an application and the scores/criteria determined by the Commission will be valid
