

# Application Criterias

## Applicants Candidates:

### a) High school last in the classroom being or in graduate in case their presence provided that:

1. Foreign nationals (provided they have not received/graduated from secondary education institutions in Türkiye [excluding foreign nationals who have completed their entire high school education in embassy schools / international private educational institutions listed in the MOBIS system, and foreign nationals who have come to our country within the framework of a project carried out by the Ministry of National Education or the Higher Education Council])
2. Those who were born Turkish citizens but lost their Turkish citizenship by obtaining permission from the Ministry of Interior to renounce it, and those who can document that they hold a blue card issued to those who have lost their Turkish citizenship upon request (provided that they have not received/graduated from secondary education institutions in Türkiye or the TRNC [Turkish Republic of Northern Cyprus] ) (Candidates applying for admission quotas from abroad should review Article 7 of the Turkish Citizenship Law No. 5901).
3. Those who acquired Turkish citizenship later while being foreign nationals / dual nationals in this situation (provided that they did not receive education / did not graduate from secondary education institutions in Türkiye and the TRNC)
4. Including those who completed their entire secondary education [high school] in Turkish schools opened under the Ministry of National Education in a foreign country outside the TRNC)
5. And who meet the criteria specified in the GCE AL, TR-YÖS or the application and admission guidelines approved by the Council of Higher Education of higher education institutions.

**b) From the candidates,**

1. Turkish citizens who have completed all of their secondary education (high school) in Türkiye or the Turkish Republic of Northern Cyprus,
2. Those who are citizens of the TRNC / dual citizens whose one nationality is the TRNC (excluding those who have completed all of their secondary education (high school) in high schools in the TRNC and have/will have GCE AL results, or those who are citizens of the TRNC and have completed all of their secondary education (high school) in a foreign country and meet the criteria for student admission as specified in the TR-YÖS or the application and admission guidelines approved by the Council of Higher Education of higher education institutions ),
3. Dual citizens whose first nationality by birth is the Republic of Türkiye, as defined in Article 7 of the Turkish Citizenship Law No. 5901 (excluding those who meet the conditions in clause 4 of clause (a))
4. Turkish citizens or dual citizens whose first nationality by birth is Turkish as defined in Article 7 of the Turkish Citizenship Law No. 5901, who are studying at schools within embassies in Türkiye or at foreign high schools located in Türkiye.
5. a) Turkish Cypriot citizens and those who have renounced Turkish citizenship/Blue Card holders who are studying or have graduated from secondary education (high school) institutions in Türkiye and the Turkish Republic of Northern Cyprus.  
b) Foreign nationals who are studying or have graduated from secondary education (high school) institutions in Türkiye (excluding foreign nationals who have completed their high school education in embassy schools / international private educational institutions listed in the MOBIS system, and foreign nationals who have come to our country within the framework of projects carried out by the Ministry of National Education or the Higher Education Council)
